

**OFFICIAL RULES FOR THE
“Seat in Vegas with Richmond International Raceway® Sweepstakes”**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR
CHANCES OF WINNING**

SWEEPSTAKES PERIOD: The “Seat in Vegas with Richmond International Raceway® Sweepstakes” (“Sweepstakes”) begins August 26, 2013, 12:00 a.m. EDT and ends 11:59 p.m. EDT on October 11, 2013 (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there are two (2) ways to enter: **(1) Online:** Visit www.rir.com and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes. All online entries must be submitted by October 11, 2013 at 11:59 p.m. EDT to be eligible. **(2) Via Mail:** Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: Seat In Vegas with Richmond International Raceway Sweepstakes, 600 E. Laburnum Ave, Richmond, VA 23222. All mail-in entries must be postmarked by October 11, 2013 and received by October 17, 2013 to be eligible. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household, regardless of method of entry. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated, misdirected, or postage-due entries or mail. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia, excluding Rhode Island, who are of the age of majority or older in the applicable jurisdiction. Employees of Richmond International Raceway, Inc. (“Sponsor”), and its parent, subsidiaries, limited liability and affiliated companies, and advertising and promotion agencies, and each of their respective family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside), and members of their households, whether or not related, are not eligible to enter or win. may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding, and that any dispute resolution proceedings will be conducted only on an individual basis and not in a class, consolidated or representative action. **You agree to waive any right to a jury trial or to participate in a class action.**
