

## OFFICIAL RULES FOR THE “Richmond International Raceway Ultimate Fan Access Weekend Sweepstakes”

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING**

**SWEEPSTAKES PERIOD:** The “Richmond International Raceway Ultimate Fan Access Weekend Sweepstakes” (“Sweepstakes”) begins on April 22, 2014 at 12:01 AM Eastern Standard Time (“EST”) and ends on August 9, 2014 at 11:59 PM EST (the “Sweepstakes Period”).

**HOW TO ENTER:** During the Sweepstakes Period, there are two (2) ways to enter: **(1) Online:** Visit [www.rir.com/Fan-Corner/Ultimate-Fan-Access-Weekend.aspx](http://www.rir.com/Fan-Corner/Ultimate-Fan-Access-Weekend.aspx) and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes. All online entries must be submitted by August 9, 2014 at 11:59 PM EST to be eligible. **(2) Via Mail:** Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: “Richmond International Raceway Ultimate Fan Access Weekend Sweepstakes” C/O Richmond International Raceway, Inc., 600 E. Laburnum Ave, Richmond, VA 23222. All entries must be postmarked by August 9, 2014, and received by August 16, 2014, to be eligible. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household, regardless of method of entry. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated, misdirected, or postage-due entries or mail. Employees of Richmond International Raceway, Inc. Pace car rides are subject to weather conditions. Cold pit passes are subject to the rules and regulations of Richmond International Raceway, Inc. and any applicable sanctioning body.
